

Guidelines for Visiting the State Museum at Majdanek and its Branches in Belżec and Sobibór During the SARS-CoV-2 Epidemic.

Order Regulations

1. Every person present within the grounds and the structures of the State Museum at Majdanek or its branches is obliged to cover their mouth and their nose with their own personal protection equipment.
2. Every person present within the grounds, exhibition spaces, and historic objects of the State Museum at Majdanek and its branches is obliged to keep a minimum 2-metre distance from others (excluding families and guardians of the disabled).

Rules Regarding Exhibition Attendance and Visitor Service

1. During the ongoing COVID-19 pandemic, the grounds, exhibitions, and historic buildings of the State Museum at Majdanek and its branches are available in accordance with strict sanitary regulations that ensure the safety of both the visitors and the employees of the museum.
2. Visits to the State Museum at Majdanek and its branches in Belżec and Sobibór can take place as individual tours or in groups of a maximum of 10 people.
3. Guide services for individual visitors and organised groups of up to 10 people are made available again.
4. At the State Museum at Majdanek, individual visitors can use guide services as part of a tour organised in rounds at scheduled times. The number of visitors per round may not exceed 10 people. More details on www.majdanek.eu.
5. For reasons of sanitary safety, visitors using guide services are recommended to provide their name, surname and telephone number (or other contact details).
6. Visitors using guide services are asked to cover their mouths and nose using their own personal protective equipment throughout the entire tour.
7. The museum introduces a limit of visitors that can be simultaneously present inside the objects housing exhibitions and the visitor service centres. The detailed information concerning the admission restrictions is available at the entrance to particular structures.
8. Visitors attending the “Prisoners of Majdanek” exhibition in barracks no. 62 in the State Museum at Majdanek as well as the permanent exhibitions in Belżec and Sobibór (museum buildings) are obliged to disinfect their hands at the points of entry. The disinfectant is available at the entrance of each building. This rule applies to all visitors, those wearing gloves included.

9. When visiting, keep a safe distance of at least 2 metres from other people (excluding families and guardians of the disabled).
10. Before entering the visitor service centres or attending the museum information points, the visitors are obliged to disinfect their hands at the points of entry. The disinfectant is available at the entrance of each building. This rule applies to all visitors, those wearing gloves included.
11. Only one person can be directly present at the information and distribution points. The remaining visitors are obliged to await for their turn to be attended, keeping a minimum 2-metre distance from other visitors (excluding families and guardians of the disabled).
12. All purchases and transactions should be conducted with the use of cashless methods of payment, if possible.

The Rules and Regulations Concerning Visiting the State Museum at Majdanek and its Branches in Bełżec and Sobibór During the SARS-CoV-2 Epidemic are applied temporarily and independently from the standard Rules and Regulations concerning visiting the State Museum at Majdanek and its Branches in Bełżec and Sobibór implemented through the decree no. 3/2018 by the Director of the State Museum at Majdanek on March 21, 2018.
